A-302 ALUMINUM BRIGHTENER

The appearance of weathered aluminum cleaned with this formula is quite different from the appearance of aluminum cleaned with traditional formulations. In addition to better cleaning, the formulation gives a brighter appearance without severe localized pitting.

A-302 should not be applied to glass. However, if the formulation does contact glass, prompt water rinsing will prevent etching.

Use 5 gallons of **A-302** per 50 gallons of water during the summertime and 7 to 8 gallons per 50 gallons of water in the winter. This diluted solution is sprayed on the dirty aluminum by drenching from bottom to top, then down again to the bottom. In 3 to 5 minutes, before the foam begins to gall and streak, a similar bottom-to-top-to-bottom rinse with clean water is applied, leaving a clean and bright aluminum surface.

NOTE: For stainless steel, use the same formula used for aluminum. The inhibitive properties of this formulation prevent attack of the stainless steel so very little foam is generated. Spot mopping of milk stains may be required.
