# DERMA-WASH SANITIZING HAND SOAP

### APPLICATION

**DERMA-WASH** is acceptable as a hand washing and sanitizing compound for use in official establishments operating under the federal meat and poultry products inspection program.

This formulation effectively reduces bacterial flora of the skin. Hands need not be washed prior to using this product. For one-step hand washing and sanitizing, place approximately 5 cubic centimeters of **DERMA-WASH** in the palm of your hand, add 15 cubic centimeters of water, lather and wash in a normal manner. After use, hands must be thoroughly rinsed with potable water. Repeat whenever reentering food production area. This product must be dispensed from an adequate dispenser located a sufficient distance from the processing line to prevent accidental food contamination.

### CAUTION

Do not get in eyes. Harmful if swallowed. Avoid contamination of food. Remove and wash contaminated clothing before entering food processing areas.
