TYPICAL APPLICATIONS

OXY-SAFE is recommended for use on rubber conveyor belting, filter press bags such as are in use in the wine and juice industry, and other chlorine-sensitive materials.

CONCENTRATED

OXY-SAFE's heavy-duty allows low use-solution concentrations, resulting in low-cost cleaning with optimum performance.

MODERATE FOAMER

OXY-SAFE provides a moderate amount of foaming to aid in soil penetration during cleaning processes. Foam levels assist in making solution contact on upper portions of conveyors and vessels.

FREE-RINSING

Chelants and wetting agents in **OXY-SAFE** are carefully selected to provide excellent rinse ability and inhibit the formation of calcium carbonate (CaCO₃) precipitate in the rinse cycle.

AUTHORIZATION

OXY-SAFE is acceptable as a general cleaning agent on all surfaces, or for use with steam or mechanical cleaning devices in all departments of official establishments operating under the federal meat, poultry, shell egg grading, and egg products inspection programs.

SAFETY & HANDLING PROCEDURE

Wear goggles and gloves when handling this product. Keep out of reach of children. Do not add **OXY-SAFE** to strong oxidizing agents, such as chlorine.

GENERAL DIRECTIONS

For cleaning filter press bags, use 35 pounds **OXY-SAFE** and sufficient amount of alkali (.05% to 1% caustic) and circulate in 140°F water for a minimum of 30 minutes. Rinse thoroughly.

For conveyor belt cleaning, wet belts with warm water and broadcast **OXY-SAFE** on belts and brush or scrub pads. Rinse thoroughly.
