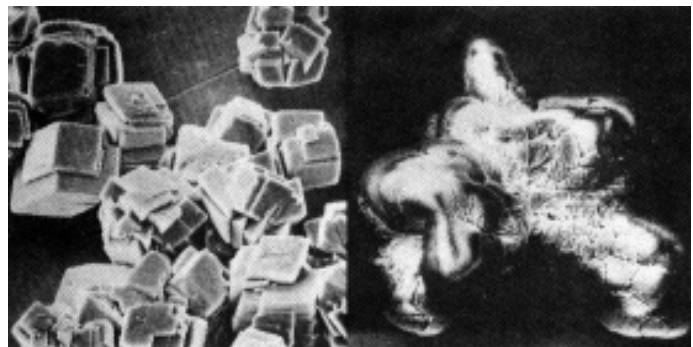

**SURE FLOW® C** is a water treatment formula designed to reduce plugging of orifices and distribution piping. Protected systems stay cleaner. Clean systems stay open and flowing at designed rate. System maintenance costs may be greatly reduced and water pumps are protected from excessive operating pressure.

**SURE FLOW® C** helps remove mineral buildup from irrigation systems with existing mineral buildup. An initial feed rate will be recommended based upon water quality analysis. Once a system is free from deposits, a lower feed rate will help maintain the system. **SURE FLOW® C** is best added by continuous injection that is proportional to water flow rates. It is compatible with most fertilizers and soil building products. A simple test of mixing **SURE FLOW® C** with a small amount of fertilizer or soil builder is necessary to insure compatibility.

**SURE FLOW® C** is not a replacement for pH adjustment or problems caused by heavily silt-laden water. It will reduce problems related to the calcining of soil by water with high hardness content.
