INDUSTRIAL ANTIFOAM / DEFOAMER

APPLICATION

This product is a new high technology defoamer developed especially for architectural and industrial coatings that are formulated with associative thickeners. **PRODUCT 712** has also been found particularly effective at inhibiting the foaming action common to industrial waste waters. Its ability to quickly knock-down the foaming action is useful in applications with substantial agitation.

DOSAGE

Use at the rate of 1 ounce per 10 square feet of surface area to be treated. If foaming persists, slightly higher quantities of the product may be needed.

FEEDING TECHNIQUE

Apply directly to system at a point of moderate agitation, or dilute with warm water and apply by any convenient method.

SAFETY AND HANDLING PROCEDURE

PRODUCT 712 is a relatively neutral product. Even though no effects are anticipated due to exposure to this product, the standard precautions should be taken for handling industrial chemicals of this type (safety gloves and goggles).
