ACTIVATOR DW PART TWO OF A TWO-PART SYSTEM FOR GENERATING CHLORINE DIOXIDE IN A CH₂O CHLORINE DIOXIDE GENERATOR

APPLICATION

Chlorine dioxide is generated in the CH₂O chlorine dioxide generator through the process of reacting a sodium chlorite solution with an acid activator. **ACTIVATOR DW** is an acid activator designed to give the most complete and efficient conversion of these two components to chlorine dioxide.

DIRECTIONS FOR USE

Depending on the product to be activated and the generator design, **ACTIVATOR DW** is introduced into the generator at a metered rate to produce chlorine dioxide from **IVR-SAN 7.5, IVR-SAN 15, AQUA CLEAR 15, or CLEAN FINISH. ACTIVATOR DW** is intended to be used for the activation of sodium chlorite solutions in chlorine dioxide generators only, and should never be added directly to the sodium chlorite solution by any other means.

ACTIVATOR DW may also be used to lower pH in a variety of water systems. Add as necessary to obtain the desired pH level. Dosage will vary depending upon water conditions.

SAFETY & HANDLING PROCEDURE

ACTIVATOR DW is a moderately acidic product. Contact with the material can cause severe burns; prolonged contact with material will destroy tissue. Complete safety equipment must be worn when handling product. Wear impervious gloves, safety goggles and face shield, as well as protective clothing, boots, and respiratory protection as necessary to minimize contact with product.

CAUTION: When added to water, **ACTIVATOR DW** will reduce pH and increase chloride level. As such, it may cause damage to system metal or other components if not properly monitored. The customer should consult the equipment manufacturer to insure compatibility prior to addition.

Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. It is the customer's responsibility to monitor and maintain treatment levels.
