### HISTORY

### OPERATIONAL CONSIDERATIONS

Unit requires 110V, 15 amp outlet  
Unit measures 2' wide x 4' high on board

The AgriSystem 5 (Silver) comes equipped with an FT430 Flow Controller. When used with a flow meter (*not included with unit*) the unit is capable of proportional flow control. This allows the unit to supply product based on the flow rate of the water system. Unit can be stand or wall mounted.

### TESTING REQUIREMENTS

Testing requirements to ensure desired residuals are being maintained include: pH, Chlorine Dioxide, Total Oxidant, and ORP.

A control test is necessary on individual plant species and/or applications to determine tolerance. Customers shall set treatment levels based on their control test results. Daily testing is recommended to maintain desired level control. It is the customer's responsibility to monitor and maintain treatment levels. Failure to monitor and maintain treatment levels can cause damage. Use only CH<sub>2</sub>O, Inc. OEM equipment with CH<sub>2</sub>O, Inc. products.
