DIRECTIONS FOR USE

ALKA-ADD 906 was created for those processors that wish to create their own cleaning solutions by diluting sodium or potassium hydroxide in water. These dilutions do not have the cleaning or rinsing ability that is produced when **ALKA-ADD 906** is introduced to the solution. **ALKA-ADD 906** imparts the qualities of a professionally formulated product to these dilutions with only a very modest increase in use-cost.

Dilute your sodium or potassium hydroxide in the manner that is preferred by you. After you have completed this process add one to two ounces per gallon of **ALKA-ADD 906** to the solution and mix it in completely before using the cleaning solution.
