DIRECTIONS

For Heavy Grease Removal:

Dilute 1 part **CLEAN-IT** with 2 to 5 parts of clear water.

For Heavy Duty Cleaning:

Dilute 4 ounces (120 ml) of **CLEAN-IT** to 1 gallon (3.8 litres) of water.

For General Cleaning:

Dilute 1 to 2 ounces (30-60 ml) **CLEAN-IT** to 1 gallon (3.8 litres) of water.

For High Pressure Washing:

Dilute 1 to 2 ounces (30-60 ml) **CLEAN-IT** to 1 gallon (3.8 litres) of water.

SAFETY & HANDLING PROCEDURE

This product is a slightly alkaline material and can be handled safely by using the standard procedures for chemicals of this type. Prolonged or repeated skin contact may cause irritation.
