# CLEAR BLUE WATER COLORANT

## PRODUCT DESCRIPTION

**CLEAR BLUE** is a concentrated liquid dye that is used to impart an appealing blue color to natural and manmade, contained water bodies. It is not for use in or application to any water that is not totally under control of the user such as a natural stream. **CLEAR BLUE** must not be applied to water that will be used for human consumption.

## GENERAL DIRECTIONS

Pour **CLEAR BLUE** from the container into the water near the shoreline. The color will mix uniformly throughout the body of water.

**NOTE:** The color imparted will slowly fade if applied to water that is treated with chlorine.

## DOSE RATE

One gallon (3.8 litres) of **CLEAR BLUE** will treat up to 2 million gallons (7.5M litres) water to a pleasant blue color. This dose rate may be incrementally increased to yield a deeper blue color if the body of water does not contain fish.

## SAFETY & HANDLING PROCEDURE

This product is a mild irritant. It is recommended that safety glasses and impervious gloves be worn when handling the concentrated product. Avoid spilling product, as the concentrated dye solution will most likely stain the surface it contacts.

Read and understand the SDS before handling or use of this product.
