EVER-KLEEN 9242 is a concentrated liquid cleaner which can be accurately and efficiently dispensed through automatic feed and control systems. It has been formulated specifically for effective cleaning and degreasing at low-use solution concentration. The result is a low-cost cleaner with optimum performance.

EVER-KLEEN 9242 provides a moderate amount of foam to aid in soil penetration during cleaning. Moderate foam levels promote cleaning solution contact in upper portions of conveyors and vessels, while maintaining ease of rinsing.

The chelates and wetting agents in **EVER-KLEEN 9242** are carefully selected to provide excellent rinsing ability and inhibit the formation of calcium carbonate (CaCO₃) precipitate in the rinse cycle.

After using **EVER-KLEEN 9242**, a potable water rinse is required on all surfaces.

SAFETY AND HANDLING

This product is an alkaline liquid. Wear chemical splash goggles and rubber gloves when handling the concentrated product and solutions thereof. Wear other protective clothing as required to minimize contact with the product and its solutions.

Do not add strong oxidizing agents such as chlorine to concentrate.

GENERAL DIRECTIONS

EVER-KLEEN 9242 can be applied by manual methods in general housekeeping operations. Dilute 1 part **EVER-KLEEN 9242** with 1 to 2 quarts water. For high-pressure spray cleaning, use 1 to 2 ounces **EVER-KLEEN 9242** per gallon of water; using warm water will enhance cleaning. After using **EVER-KLEEN 9242**, rinse cleaned surfaces with potable water.
