TYPICAL APPLICATIONS

FILTRON KC is recommended for the routine maintenance washing of PA membranes.

GENERAL DIRECTIONS

FILTRON KC is typically diluted at the rate of 10 gallons into about 150 gallons of water. For cleaning, it is recommended to increase the flow to drain and to shut off permeate flow so the use solution flows across rather than through the membrane.
