ISOPROPANOL (IPA)

TYPICAL APPLICATIONS

ISOPROPANOL is commonly used as a cleaning and sanitizing agent in areas where water cannot be used. Typically applied with clean, white rags and wiped off the surface. IPA will help remove light greases and oils at ambient temperatures.

ISOPROPANOL is a liquid at room temperature with an odor that resembles ethanol and acetone. Isopropanol is similar to ethyl alcohol in solvent properties and evaporation rates.

DIRECTIONS FOR USE

ISOPROPANOL should be applied manually using clean white rags. Apply the IPA to the rag, wipe the surface, repeat if necessary. Change the rag often to avoid re-contaminating the surface.

SAFETY & HANDLING PROCEDURE

ISOPROPANOL is an extremely flammable material. It is harmful or fatal if swallowed. When handling concentrated product, wear chemical splash goggles and impervious gloves. An organic vapor respirator is recommended for use in enclosed areas.

In case of accidental ingestion seek professional assistance or contact a Poison Control Center immediately.
