DIRECTIONS FOR USE

J-SEQUESTER is designed as an additive for assisting in the loosening and removal of mineral-based soils such as beerstone or milkstone. It is particularly effective in juice concentrators, keg washers, and any other process-cleaning task with baked-on or dried-on soils.

J-SEQUESTER is typically added to alkaline CIP solutions to enhance cleaning, although it can also be used to enhance the cleaning of foaming cleaners.

DOSAGE

J-SEQUESTER can be added at the rate of 0.25 to 2.0% based on the total volume of water. The exact dose will depend upon the severity of soils being removed. Consult your CH_2O representative for assistance in developing an effective program for your individual requirements. Final recommendations will be determined by on-site trial.

SAFETY

J-SEQUESTER is a mildly alkaline product. Improper handling can result in severe irritation and/or burns. Impervious gloves and safety glasses or goggles must be worn when handling the product concentrate.

Read and thoroughly understand the Material Safety Data Sheet before handling this product.

FEEDING TECHNIQUE

J-SEQUESTER IS A LIQUID, SO IT CAN BE PUMPED OR POURED. ITS USE CAN BE AUTOMATED BY USING A PUMP AND TIMER TO CHARGE BATCHES OF A GIVEN VOLUME. IT IS MOST OFTEN SLUG FED TO THE CLEANING SOLUTION.
