DIRECTIONS FOR USE

PRESS-KLEEN 100 has been developed to provide a safer and more environmentally friendly alternative to the solvent-based PRESS-KLEENERS. When used at proper dilution, **PRESS-KLEEN 100** will deliver outstanding cleaning results! Dilute **PRESS-KLEEN 100** at a starting solution of 2 cups of the powder to 5 gallons of warm water. At this dilution the product is not chemically aggressive to most press surfaces and can be safely and effectively used to clean dried ink buildup from the press.

SAFETY

PRESS-KLEEN 100 contains metasilicate salts, which are alkaline. Improper handling of the product concentrate can result in irritation. Impervious gloves and safety glasses must be worn when handling the product concentrate. Additional protective clothing or safety equipment may be necessary for some product applications.
