BUG-OFF CONCENTRATED PRE-WASH AND BUG REMOVER

TYPICAL APPLICATIONS

BUG-OFF incorporates various penetrating surfactants and chelants to soften and remove bugs and road film.

DIRECTIONS FOR USE

BUG-OFF is a concentrated material and must be diluted before use. Liberally apply use-solution of **BUG-OFF** to heavily soiled areas. Allow solution to remain on surface to penetrate bugs and road film, but do not allow to dry. Rinse solution and debris from surface with fresh water.

BUG-OFF can be used for various cleaning applications, according to the following recommended dilution rates.

Conventional Application: Dilute 1/2 to 3/4 gallon of **BUG-OFF** with 15 gallons of water and mix gently. Consult your CH₂O technical representative for further recommendations based upon each particular application.

High-Pressure Preparation and Washing: Dilute 1 part of **BUG-OFF** with 200 parts of water.

Low-Pressure Presoak: Dilute 1 part of **BUG-OFF** with 40 to 60 parts of water.

FREE RINSING

Select wetting agents in **BUG-OFF** provide excellent lubrication and rinsing ability, yielding a streak-free shine.

SAFETY & HANDLING PROCEDURE

BUG-OFF is an alkaline surfactant and chelate solution. Safety glasses and impervious gloves should be worn when handling the concentrated product. Impervious gloves should be worn for prolonged or repeated exposure to product use-solutions.
