For General Cleaning: Dilute 1 to 2 ounces **MARK-OFF** to 1 gallon of water.

For High-Pressure Washing: Dilute 1 to 3 ounces **MARK-OFF** to 1 gallon of water.

For Automatic Scrubbers: Dilute 1 to 2 ounces **MARK-OFF** to 1 gallon of water.
