#### DIRECTIONS

For Heavy Grease Removal:

Dilute 1 part **ORANGE BLAST** with 2 to 5 parts of clear water.

For General Cleaning:

Dilute 2 to 4 ounces **ORANGE BLAST** to 1 gallon of water.

For High-Pressure Washing: Dilute 2 to 5 ounces **ORANGE BLAST** to 1 gallon of water.

For Automatic Scrubbers:

Dilute 2 to 4 ounces **ORANGE BLAST** to 1 gallon of water.
