SAFETY & HANDLING PROCEDURE

RUST SHIELD (UK-175) is a neutral pH solution, although it includes surfactants that may be irritating to skin and eyes. Safety glasses and impervious gloves must be worn when handling the concentrated product. Impervious gloves should be worn for prolonged or repeated exposure to product use solutions.
