SEA FRESH POTABLE WATER TREATMENT

APPLICATION

Natural water sources are corrosive to metal and contain dissolved minerals such as calcium magnesium, iron and manganese.

These minerals can precipitate in distribution lines and water heaters to reduce system flow and efficiency. Certain minerals cause unsightly build-up and staining of fixtures. In some instances, hydrogen sulfide, or other natural compounds may be present, which impart undesirable taste and odors.

In turn, **SEA FRESH** has the ability to "tie up" calcium and magnesium to help prevent troublesome scale deposits. Additionally, **SEA FRESH** reacts with iron and manganese to reduce staining and fouling.

SEA FRESH provides a combination of ingredients to "tie up" minerals, which helps prevent troublesome scale deposits, and control iron stains. Additionally, the unique oxidizing agents in **SEA FRESH** can substantially reduce odors caused by hydrogen sulfide gas.

SEA FRESH is certified by NSF to meet ANSI/NSF Standard 60 at feed rates up to 150 mg/l (of product). The combination of sequestering and oxidizing ingredients are specifically designed for potable water systems, and will be useful in a widerange of other water systems such as poultry, dairy, egg washing, and greenhouses.

SAFETY & HANDLING PROCEDURE

This product is alkaline. Chemical splash goggles and impervious gloves should be worn during all handling of the concentrate. Eye contact will cause severe irritation with possible burns. Refer to the Material Safety Data Sheet for further safety and handling procedure. This product contains a chemical that is degraded by heat and exposure to UV light (sunlight). Product should be stored inside, out of sunlight exposure, unless the container is open, and the product is on-line and in use.

FEEDING TECHNIQUE

Pump directly from the shipping container into water supply line of the system. Alternatively, pump from a chemical dilution and feed tank.

DOSAGE

Chemical addition should be continuous to provide an even product concentration. Use at the rate of 4 to 14 fluid ounces per 1000 gallons of water to be treated. Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application.

CONTROL

Maintain a residual of 0.5 to 2.0 parts per million of total phosphate. Consult your CH₂O Sales Representative for further testing information.
