We have completed our review of the above-mentioned product. Based on the information that the Canadian Food Inspection Agency (CFIA) has reviewed, we have determined that these products meet all requirements as outlined in the *Fertilizers Act* and regulations and may be legally sold in Canada. Therefore, the above products have been granted registration under the *Fertilizers Act* until **February 1**st, **2024**. All labels associated with these products found in the marketplace must contain the registration number stated above.

Enclosed with this letter, you will find a copy of the signed registration certificates and a copy of the approved labels. Please ensure that the actual product labels found in the Canadian marketplace are the same as the enclosed label. Please be advised that the presence of the CFIA stamp, on the final label is only as a symbol of approval and the reproduction or use of the CFIA stamp on labels in the marketplace is prohibited and subject to enforcement if found in the marketplace. Please note that all products are required to bear a lot/batch number on the product label. As well, please ensure that all advertising claims regarding the benefits of this product are limited to those identified on the approved label.

Effective October 26, 2020, the CFIA has updated the *Fertilizers Regulations* to reduce red tape and provide more flexibility to industry while focusing on product safety and environmental protection. **These product registrations will be cancelled on October 25, 2023. To continue to market these products in Canada beyond this date, their registrations will need to be renewed under the modernized** *Fertilizers Regulations***. Please consult the CFIA's <u>Fertilizer web page</u> before submitting your reregistration in order to familiarize yourself with the new requirements.**





Please note that as new regulations and/or policies are developed, the acceptability of this product under the *Fertilizers Act* and regulations may also change. It is the responsibility of the manufacturer/registrant/distributor/retailer to ensure that the product and the label continue to meet the requirements for sale in Canada, as outlined in the *Fertilizers Act* and regulations.

Please note that an amendment to your registration must be submitted to the CFIA and approved prior to making any changes to the label, chemical composition, or constituent materials of the product (if the change could reasonably be expected to affect its performance as a fertilizer or supplement, its safety or its use).

The CFIA will accept submissions for renewal up to six months prior to expiration if there are no changes to the constituent materials or manufacturing process from the previous registration, and up to one year in advance if there are changes to the constituent materials or manufacturing process. The registrant must ensure that they are aware of the date that the product expires (found on registration certificate), and to submit their renewal application on, or before, the stated expiry date. **The CFIA will not send you a reminder**.
