Product performance is dependent upon maintaining proper chemical residuals, system operation, design, cleanliness, metallurgy, and water quality. For optimal results the following actions should be taken by qualified operational personnel:

- · Initial system cleaning and passivation;
- · periodic inspections of all system components;
- maintaining systems free from particulate matter and sludge accumulations;
- insuring proper chemical feed rates and system bleed-off;
- control of biological organisms accompanied by periodic biological testing; and,
- · daily testing and recording of chemical residuals.

Product **6322U** is formulated for evaporative/recirculating water system as part of the mineral precipitation control program. This formula gives excellent performance over a wide array of make-up water conditions and it is acceptable for use in USDA regulated facilities when the treated water does not contact edible products.

<u>ORGANIC FORMULATION</u> – **6322U** is formulated with all organic compounds. It contains no heavy metals, phosphate, or molybdate.

SAFETY & HANDLING PROCEDURE

This product is a slightly alkaline liquid. It can be safely handled using standard precautionary procedure associated with industrial chemicals of this type.

FEEDING TECHNIQUE

Inject directly into the condenser water recirculating line or the basin of the cooling tower.

CONTROL

Maintain a residual of 2 to 6 parts per million of active POSCA in the system at all times, as tested by CH_2O 's **P-2** test kit. Contact your CH_2O representative for further information on analytical testing. Daily testing is necessary for best results. Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application.

DOSAGE

Initially charge the system at the rate of 19 ounces per 1,000 gallons of system capacity. Maintain system treatment by feeding POSCA **6322U** at the rate of 3 to 5 ounces per 1,000 gallons of makeup water.
