### APPLICATION

Mineral crystallization in irrigation networks may often lead to plugging of nozzles, emitter tips and clogging of sand filters. The use of strong mineral acid washes has proven to be detrimental to pressure compensators and often impractical in removing deposits. Other disadvantages of strong mineral acids include costs and hazards of handling, storage and disposal.

**AGRI GUARD F** is specifically formulated for use as a line cleaner that inhibits mineral fouling of emitters and nozzles.

**AGRI GUARD F** allows simple on-site distribution of a chelant compound. Your program is designed and managed for optimum system performance.

### SAFETY & HANDLING PROCEDURE

This product is alkaline. Chemical splash goggles and impervious gloves should be worn during all handling of the concentrate. Eye contact will cause severe irritation with possible burns. Refer to the Safety Data Sheet for further safety and handling procedures.

### STORAGE

This product contains a chemical that is degraded by heat and exposure to UV light (sunlight). Product should be stored inside, out of sunlight exposure, unless the container is open, and the product is on-line and in use.

### FEEDING TECHNIQUE

Inject directly into the irrigation lines using CH<sub>2</sub>O, Inc. automated metering equipment. Never mix this product with other products without the use of properly tested metering equipment.

### CONTROL

Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application. Additional testing may be performed upon request.

### DOSAGE

Use only with CH<sub>2</sub>O, Inc. operating equipment. A control test is necessary for individual applications to determine tolerance. Customers shall set treatment levels based on their control test results.
