Select wetting agents in **ROAD KILL (CW-76)** foaming pre-soak provide excellent cleansing and rinsing ability.

SAFETY & HANDLING PROCEDURE

ROAD KILL (CW-76) foaming pre-soak is a moderately alkaline solution. Safety glasses and impervious gloves must be worn when handling the concentrated product. Impervious gloves should be worn for prolonged or repeated exposure to product use solutions.
