DIRECTIONS FOR USE

- 1. Simply pour 4 ounces of **SEPTI-ZYME** into stopped or slow running drain.
- Allow SEPTI-ZYME to work for 2 to 12 hours.
- 3. Repeat treatments if necessary.

<u>NOTE</u>: If an acid or caustic drain opener has been used in a stopped-up drain, wait until most of it has gone down the drain before introducing **SEPTI-ZYME**. The presence of too much acid or caustic will prevent **SEPTI-ZYME** from working at its full potential.
