UK-300 HEAVY-DUTY PRESSURE-WASHING DETERGENT

TYPICAL APPLICATIONS

UK-300 is a top quality, heavy-duty, powdered product that is designed for use as the alkaline step of a two-step truck washing process. It will neutralize acidic residuals remaining on the surface from the first step. When applied at adequate levels it is an excellent cleaner, and capable of removing remaining road scum. When properly diluted, this product is a useful multipurpose truck wash that can be used on painted, stainless steel, and aluminum surfaces.

DIRECTIONS FOR USE

UK-300 is a concentrated material and must be diluted before use. A suggested dilution of product can be made by dissolving 40 pounds of **UK-300** into 50 gallons of water, and further diluting this solution at the rate of 1 part to 25 parts water (use-solution of approximately 1 part **UK-300** to 250 parts water) during the application process.

Apply use-solution of **UK-300** liberally to all surfaces. Allow solution to remain on surface to penetrate and soften soils, but do not allow to dry. Rinse solution and debris from surface with fresh water.

Although **UK-300** was designed as the alkaline portion of a two-step truck washing system, it can be used for various cleaning applications. Use the following recommended dilution rates.

DIRECTIONS FOR USE (continued)

Cleaning engines, tires, whitewalls and rims: Add 1 to 2 pounds of **UK-300** into 10 gallons of water and mix to dissolve. Consult your technical representative for further recommendations based upon each particular application.

Pressure-washer cleaning of general surfaces: Add 1 to 2 pounds of **UK-300** into 30 gallons of water and mix to dissolve.

Select wetting agents in **UK-300** provides excellent rinsing ability yielding a superior shine.

SAFETY & HANDLING PROCEDURE

UK-300 is an extremely alkaline product. Safety glasses and impervious gloves must be worn when handling the concentrated product. Impervious gloves should be worn for exposure to product use-solutions.
