# FP WASH

## For Use on Processed Fruits and Vegetables

### APPLICATION

**FP WASH** is a concentrated formula that can be used to wash and help reduce spoilage organisms, including yeast, mold and bacteria on processed fruit and vegetables. This product conforms to the requirements listed in 21 CFR 173.315 for this purpose, when used in accordance with the referenced citation. **FP WASH** must be diluted properly before use, and the use of **FP WASH** must be followed by a potable water rinse to remove, to the extent possible, residues of the product.

**FP WASH** is a liquid cleaner so it can be dispensed accurately and efficiently through automatic feed control equipment.

**FP WASH** provides a slight foaming action to aid in soil penetration and removal during the cleaning process, and allows for ease of rinsing.

### CONTROL

Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application. Additional testing may be performed upon request.

### GENERAL REGULATORY STATEMENT

**FP WASH** is formulated in conformance with 21 CFR 173.315, and contains ingredients listed specifically in this citation, or other ingredients that are generally recognized as safe in food or covered by prior sanctions. Contact your CH<sub>2</sub>O representative if more information is needed on specific regulatory compliances.

### SAFETY & HANDLING

**FP WASH** in its concentrated form is very acidic and must be handled properly. Although it is not combustible, it is an oxidizer that can react with incompatible materials and enhance their combustion. It is necessary to read and understand the SDS for this product before handling or use to determine the required personal protective equipment necessary to avoid personal injury.

Properly diluted use solutions of **FP WASH** are more benign and much more easily handled.

### GENERAL DIRECTIONS

**FP WASH** is a concentrate and must be diluted before use.

For general cleaning, add **FP WASH** to wash water at the rate of 1/2 to 1 fluid ounce per 15 gallons of water.

After washing processed fruits and vegetables with **FP WASH**, a subsequent rinse with potable water is required to remove any chemical residues.
