# APPLICATION

**ISO-CUT 220** is a heavy-duty cutting and grinding fluid formulated for wet grinding and cutting of both ferrous and nonferrous metals. **ISO-CUT 220** mixes with hard and soft raw water sources. **ISO-CUT 220** is a synthetic, water-soluble coolant, which is fluorescent in color for excellent visibility in grinding and cutting conditions. This product contains no nitrites, borates, heavy metals, or oils.

## **SAFETY & HANDLING PROCEDURE**

**ISO-CUT 220** will help clean the residual deposits from grinding wheels. **ISO-CUT 220** is a concentrated, water-soluble formulation for maintaining an "open" grinding wheel.

Clean sump and all circulation lines of old product and grinding deposits. Do not mix with old coolant.

# CAUTION

To prevent the development of rust with some metals, a maximum dilution of 40:1 should be implemented.

#### **INGREDIENTS**

**ISO-CUT 220** is a blend of synthetic coolants and lubricants in addition to corrosion inhibitors in a pH buffered solution. If further information is required, please contact your CH<sub>2</sub>O Technical Representative.

## CONTROL

Daily testing is recommended to maintain proper control. Failure to monitor and maintain treatment levels can cause damage. In addition to monitoring and maintaining treatment levels, it is the customer's responsibility to ensure the product is fit for its intended application. Additional testing may be performed upon request.

## DOSAGE

Dilute **ISO-CUT 220** according to the following uses.

Light-duty grinding of steel or nonferrous metals, 1 part **ISO-CUT 220** to 30-80 parts water.

Grinding cast iron, 1 part **ISO-CUT 220** to 30-80 parts water.

Heavy-duty grinding, 1 part **ISO-CUT 220** to 10-50 parts water.

Rust prevention tip, 1 part **ISO-CUT 220** to 50 parts water for best results.
