DIRECTIONS

For Heavy Grease Removal:

Dilute 1 part **POWER PLUS** with 2 to 5 parts of clear water.

For General Cleaning:

Dilute 1 to 2 ounces **POWER PLUS** to 1 gallon of water.

For High Pressure Washing:

Dilute 1 to 3 ounces **POWER PLUS** to 1 gallon of water.

For Automatic Scrubbers:

Dilute 1 to 2 ounces **POWER PLUS** to 1 gallon of water.
